James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Fred Soisson, and Tracy Plessinger, William Davis, and Bob Munshower.

The minutes of the March regular meeting were read. Fred Soisson made a motion to approve the minutes as presented. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

#### Visitors

None.

#### Public/Supervisor Comment

Mr. Davis and Mr. Munshower asked several questions about the township's Act 537 plan and the amendment that we have filed to that plan proposing to include the Glendale Yearound Sewage System. The supervisors answered the questions and explained briefly the current township position on the inclusion of the Yearound system in the municipal system. Mr. Davis requested that he receive a copy of the proposed amendment which the township has filed with PADEP. The secretary will send a copy of the amendment to Mr. Davis.

#### Old Business

Our Act 537 amendment has been rejected by PADEP. Our engineers and solicitor have recommended that we appeal that decision to the Environmental Hearing Board. Tracy Plessinger made a motion to appeal the denial of our proposed Act 537 amendment and to instruct our solicitor and engineer to take all necessary steps to carry out the appeal. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye.

In connection with the discussion of the Act 537 ammendment denial, the supervisors also discussed the letters that we have received from PADEP in response to our letters of inquiry concerning the Glendale Yearound situation. Tracy Plessinger made a motion that the secretary draft letter of response to correct the factual inaccuracies in the PADEP letters and to restate the township's position. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye.

#### New Business/Secretaries Report

A discussion was held concerning possible road projects for this summer. The roadmaster suggested the paving of Black's Lane and improvement of drainage on Swartz Road near the Yearound entrance. Tracy Plessinger made a motion to complete the paving of Black's Lane and drainage project on Swartz Road. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye.

#### Payment of Accounts

Tracy Plessinger made a motion to pay bills as listed on treasurer's report and approve same. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye. Treasurer's report is attached.

Meeting adjourned at 8:25 pm.
