Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collectors account.

The secretary reported that we have received a letter from PADEP in regard to the resolution we have passed releasing the township from all obligations regarding the Glendale Yearound Water and Sewer Systems. PADEP has advised us that we are responsible for the proper operation of the plant. The secretary presented a proposed letter of response which has been approved by our solicitor. Tracy Plessinger made a motion to approve and send the letter as presented. Jim Luther seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported on the progress of the Glendale Valley sewer and water project. The current funding offered by USDA Rural Development for the water project proposes a \$1000 tap fee with an average monthly fee of \$49. No definite offer for the sewer project has been made yet.

New Business/Secretaries Report

The secretary reported that we must pass several resolutions relative to the township's NIMS certification.

Tracy Plessinger made a motion to approve the National Incident Management System Implementation Plan as presented and authorize township officials to execute same. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for July. Jim Luther seconded the motion. A vote was taken. All three supervisors voted aye.
