James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger; Ryan Plessinger, Dana McGarvey, Phyllis Murray, Tom Dedea, Clyde Hankey, Dan Havrilla Jane Snyder, and Bob Munshower.

The minutes of the July regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Visitors

Dana McGarvey, a resident of Beccaria Township addressed the supervisors regarding the proposed placement of a "half way house" in Beccaria Township on Heverly Road. The facility would house female former prison inmates and provide education and training to help them integrate back into society. Mrs. McGarvey expressed concerns that the facility will bring an unwanted element into the area. Her appearance at the White Township meeting was for informational purposes only and no action on the part of the White Township supervisors is required.

Ryan Plessinger addressed the supervisors about the progress of his eagle scout project. He presented a outline of the project goals and timeline. He requested that the township provide a location on township property for the war memorial, that the township receive, hold, and expend funds collected for the project, and that the supervisors provide funds for an informational/fundraising letter to the Glendale area. The final project will be presented to the supervisors for approval before any construction begins. Neal Maneval made a motion to provide funds for the informational/fund raising letter with a maximum expenditure of \$600. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Public/Supervisor Comment

Several residents asked questions regarding the painting of lines on Swartz Road. The supervisors responded that line painting is planned and will be done as soon as a contractor is available. The residents also asked whether or not it is possible to have a speed limit posted on Swartz Road. After discussion it was decided that the secretary will check with PennDOT on the requirements for such postings.

Old Business

The secretary reported that Mrs. Sandy Shomo has signed and returned the agreement to allow her to use an existing septic system on her property on Foster Road.

Jack Bowling has begun to comply with the requirement set forth in the agreement he signed allowing his trailer to remain on a non building lot. We have also received a letter from the Cambria County Conservation District regarding Mr. Bowling placing fill along the Clearfield Creek. They have referred us to our Flood Plain Ordinance. Based on our ordinance it appears that all fill within 50 feet of the stream bank must be removed. The secretary will forward a copy of our ordinance to the solicitor for review and advice.

The secretary reported that the GVMA and Reade Township Supervisors have approved the proposed sale agreement for the purchase of the Glendale Yearound Sewer and Water Systems. The next step is for the authority to pay a \$10,000 deposit. The White Township supervisors had previously approved a loan to GVMA for this purpose and payment of that loan is included in this month's expenditures. After the deposit is paid, the proposed sale will be presented to the PUC for approval.

New Business/Secretaries Report


