James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, Bill Davis, Tom Dedeo, and Bob Munshower.

The minutes of the November regular meeting were read. James Luther made a motion to approve the minutes as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Old Business

Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collector's account.

The secretary updated the supervisors on the progress of the Glendale Valley water/sewer project. Our applications have been submitted and are pending USDA Rural Development approval. The GVMA board must make decisions concerning tap fees for the funding application to proceed.

Ryan Plessinger's Eagle Scout project has been submitted for approval.

New Business/Secretaries Report

The secretary presented the final budget for 2007. The budget projects total income of \$114,150, total expenditures of \$95,800, with a surplus of \$18,350. Proposed tax rates for 2007 are 1.5 mils for Real Estate, \$5.00 for Emergency and Municipal Services Tax, 0.5% for Real Estate Transfer, and 0.5% for Earned Income. Neal Maneval made a motion to approve the final budget for 2007. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Krumenaker Lumber has bonded Swartz Road.

Prince Gallitzin State Park is forming a "Park Friends" group to act as an advisory committee for park personnel. Since the park is located in White Township, it would be good to have a township supervisor serving on that board. Neal Maneval volunteered to attend the next organizational meeting of the group.

Early next year the township will be asked to appoint two representatives to the Glendale Recreation Commission board. These do not necessarily need to be elected officials.

As required by statute, the supervisor's Annual Reorganization meeting must be held on Tuesday, January 2, 2007. The auditors Annual Reorganization meeting must be held on Wednesday, January 3. The secretary will advertise these meetings as required by the statute.

The CCBCEA has hired two full time building inspectors to replace MDIA This has been the goal of CCBCEA since its inception and it is hoped that they will be able to provide better service with employees than with a third party agency.

Tracy Plessinger made a motion to approve the receipts and disbursements for December. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for November. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 7:35.
