James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, Sgt. Bonin of the PA State Police, and citizens Bill Davis and Tom Dedea.

The minutes of the November regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

#### Visitors

Sgt. Bonin, of the Ebensburg State Police Barracks addressed the board regarding police protection in White Township. He specifically emphasized his desire to work with Yearound residents to form a neighborhood watch program in the Yearound development. Tom Dedea said that he would talk with members of the POA board and encourage them to contact Sgt. Bonin.

#### Public/Supervisor Comment

#### Old Business

There will be a pre-hearing conference on December 17 to set the date and topics of the PUC hearing regarding the GVMA's purchase of the Yearound utilities.

Our approved Act 537 amendment has been forwarded to PADEP for their consideration.

We have received a bill from Grannas Brothers for our summer road project. It is included for payment with this month's bills.

Deborah Sedlmeyer at CCSEA is still reviewing the proposed trailer/on-lot sewage ordinance. The supervisors will wait for her comments before taking any action.

There was a discussion of speed and weight limit studies on township roads. Neal Maneval made a motion to approve the studies with a cap of \$2000 for the combined studies. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported that Ryan Plessinger has received \$4,000 in contributions for the White Township Veteran's Memorial. Also, the state park is contributing two flag poles for the project. The planning for the project will be done over the winter with construction to be done in the spring.

#### New Business/Secretaries Report

The secretary presented a final budget for 2008. The budget projects total income of \$131,011, total expenditures of \$100,800, with a surplus of \$30,211. Proposed tax rates for 2008 are 1.5 mils for Real Estate, \$5.00 for Local Services Tax, 0.5% for Real Estate Transfer, and 0.5% for Earned Income. Tracy Plessinger made a motion to approve the final budget for 2008. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported that the annual reorganization meeting for supervisors must be held on Monday, January 7, 2008 and for auditors on Tuesday, January 8, 2008. The secretary will advertise same as required by law.

A discussion was held regarding a Christmas bonus for the custodian. Neal Maneval made a motion to give the custodian a \$50 Christmas bonus. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

James Luther made a motion to approve receipts and disbursements presented for December and also any receipts and disbursements needed to close out accounts for the end of the year. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for November. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 7:51 PM.
