James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, and Dave Cunningham of Keller Engineers.

The minutes of the November regular were read. Tracy Plessinger made a motion to approve the minutes as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Old Business

The secretary updated the supervisors on construction of the new township/GVMA building. All permits are now in place and construction will progress as weather allows. McCloskey Builders do not break for the winter months so construction will progress throughout the winter. Completion is expected sometime in March. The secretary also reported that the low quote on pumping for the septic holding tank for the building was submitted by Eckenrode Septic Service. The cost will be \$145/pumping.

After consulting with the flag pole provider and landscape architect the design for the war memorial has been altered to include one pole instead of the originally designed three poles. Also, to better match the design of the memorial a new flag pole will be purchased rather than reusing the poles donated by Prince Gallitzin State Park. Neal Maneval made a motion to approve the changes to the war memorial. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

New Business/Secretaries Report

The tentative budget for 2009 has been advertised as available for inspection. Neal Maneval made a motion to approve the budget as advertised. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary has been contacted by Prince Gallitzin State Park about placing "Snowmobile Crossing" signs on Beaver Valley Road. More information will be acquired from the park and PennDOT before a final decision is made about placing the signs.

A letter has been received from Bonnie Plessinger resigning her position as tax collector effective January 31, 2009. Tracy Plessinger made a motion to accept the resignation. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

The township has received a letter from PADEP regarding an investigation of a possible hazardous site at 7-H Skeet Club. No action by the township is required.

Tracy Plessinger made a motion to approved receipts and disbursements for December. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for November. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.
