No supervisors expressed a desire to serve as the township's representative so two community members will be appointed. The secretary will seek volunteers for the position.

New Business/Secretaries Report

Krumenaker Lumber has requested release of their bond on Swartz Road. The road master reported that no excess damage or wear occurred during the bonding period so the bond may be released.

The secretary reported on an inspection of the James Bowling property at 541 Foster Road. There appear to be violations of the building codes and sewage regulations. In addition the property is classified as non-building. The secretary presented a copy of a letter that he proposes sending to Mr. Bowling. Tracy Plessinger made a motion to send the letter as presented to Mr. Bowling pending review and approval by our solicitor. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The CCSEA has prepared a sample resolution regarding 10 acre exemptions. The resolution would prevent property owners from misusing the 10 acre exemption rule. After discussion, action on the 10 acre exemption resolution was tabled.

Tracy Plessinger made a motion to approve the receipts and disbursements for February. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for January. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.
