Three quotes have been obtained and the GVMA has authorized its manager to choose a machine to recommend at this month's meeting. This will be a joint purchase between White Township and GVMA. Tracy Plessinger made a motion to purchase a copier/printer/scanner/fax machine jointly with GVMA. The cost of the machine is not to exceed \$8,000. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported that we still need to approve a personnel manual.

#### New Business/Secretaries Report

The secretary reported that he has received a quote from Larry Noel for lettering the new municipal building. The price will be \$1,200 - \$1,500. After discussion, it was suggested that we seek another quote before making a final decision.

Tracy Plessinger made a motion to approve receipts and disbursements for February. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.
