The secretary reported on the progress of the construction of our new building. With the winter weather conditions, construction is slow but the contractor is still hoping to complete the project by April.

The secretary has received information regarding the placement of snowmobile crossing signs on Beaver Valley Road. Technically the township is responsible to purchase, install, and maintain the signs. However, we could reach an agreement with the state park to do those things on our behalf. The secretary will contact the state park about what part of the costs they are willing to cover. There was also a question about what a "snowmobile crossing" is from a legal standpoint. Is it the same as a crosswalk, which requires people to stop? The secretary will check with PennDOT on this question.

New Business/Secretary's report

The chairman has contacted Carol Brink about the tax collector's position. She has expressed an interest in the position in the past. Tracy Plessinger made a motion to appoint Carol Brink as tax collector until the next municipal election. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary presented an open records policy resolution to bring the township into compliance with the state's new open records/right to know law. The policy designated Tracy Plessinger as the open records officer. Tracy Plessinger made a motion to approve the open records resolution as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

We have received a letter of resignation from our Kirk McCulley, our Emergency Management Coordinator. Neal Maneval made a motion to accept Kirk McCulley's resignation. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Neal Maneval made a motion to appoint Tracy Plessinger as the Emergency Management Coordinator. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The supervisors discussed a property dispute involving a right-of-way in the McGough subdivision. Although the township approved the subdivision, the right-of-way is private property and not a township right-of-way so

the dispute is a private dispute between the property owners involved and the township is not required to enforce the right-of-way boundaries.
