The minutes of the June regular meeting were read. Tracy Plessinger made a motion to approve the minutes as presented. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye.

#### Public/Supervisor Comment

The roadmaster asked if there was any objection to hiring someone to cut brush and grass along townships roads. The concensus of the board was that the roadmaster had the authority to contract for such work at any time that he felt is was necessary.

Jim Luther suggested that Diane Gaul could brick up the coal bin door while she is boarding up the basement windows. The secretary will contact Diane about this project.

#### Old Business

The bids for the summer road project were opened at 7:10 pm. The only bid received was from New Enterprise Stone and Lime Co. in the amount of \$23,247.10. Tracy Plessinger made a motion to accept the bid from New Enterprise. Fred Soisson seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary updated the supervisors on the status of the Glendale Yearound Sewage Treatment Plant relating to our Act 537 Plan. To date we have received no additional information from DEP. A discussion followed where concerns were expressed by the supervisors that the township is ultimately responsible for the proper maintenance and operation of the Glendale Yearound plant and therefore should have a voice how the Glendale Yearound sewage is handled. A motion was made by Fred Soisson to amend the township's Act 537 Plan to include municipal sewage service to the Glendale Yearound and to properly advertise the proposed change. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

Permits have been issued for building on property along Swartz Road.

There was a discussion of needed office space and equipment for the township secretary. The matter was tabled for future consideration.

#### New Business/Secretaries Report

The secretary presented the minutes and agenda from the July meetings of the CCSEA and CCBCEA. He also reported that he has been elected chairman of the CCBCEA board.
