

July 9, 2007

James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger; Sergeant Bonin, commander of the Ebensburg State Police Barracks, Christian Gohn, Jane Snyder. Dave Krug arrived at 8:00 PM.

The minutes of the June regular meeting were read. James Luther made a motion to approve the minutes as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

#### Visitors

Sergeant Bonin introduced himself as the newly appointed commander of the PA State Police barracks in Ebensburg. He reported on efforts of the Ebensburg barracks to investigate drug dealings in the northern Cambria County area. He stated that drug dealing is proliferating in White and Reade Townships, especially in the Glendale Yearound Development. He also reported on ongoing traffic patrols on Route 53 between Ashville and the Clearfield County line. The supervisors mentioned a problem with speeding on SR 1021 through Beaver Valley, especially during school dismissal. The supervisors also asked Sergeant Bonin his thoughts on establishing a local police force. He responded that if a local force is instituted care should be taken that it is well trained and well equipped and that while local forces are effective at enforcement issues such as traffic violations, they are often not able to handle the more serious drug related crimes. Sergeant Bonin also answered questions from the Glendale Yearound residents in attendance and agreed to attend one of their POA meetings.

#### Public/Supervisor Comment

Christian Gohn and Jane Snyder asked several questions regarding the acquisition of the Glendale Yearound water and sewer systems by the GVMA. The supervisors pointed out that the purchase was on the agenda and questions would be answered when that item was discussed. Also details concerning potential rates, etc. are best answered at the GVMA meetings.

#### Old Business

The secretary presented a proposed letter/agreement to be sent to Mrs. Sandy Shomo to allow her to use an existing septic system on her property on Foster Road. Tracy Plessinger made a motion to approve the letter/agreement as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Mr. Kevin Hahn has had testing for an on-lot system done on his property off of Beaver Valley Road. The testing has passed and he is planning on proceeding with the permitting of an on-lot system.

Ryan Plessinger has received approval for his Eagle Scout project. He will be making a presentation to the supervisors at a future meeting.

The secretary presented a proposed agreement between the GVMA and the Ludwig Rudel, owner of the Glendale Yearound Water and Sewer Companies. The agreement stipulates a purchase price not to exceed \$1,925,000 with a \$10,000 deposit. The acquisition is being financed by M&T Bank and does not require a municipal guarantee. There was a discussion of the agreement including questions from the Glendale Yearound residents present. Tracy Plessinger made a motion to approve the proposed purchase agreement between GVMA and Ludwig Rudel pending its approval by GVMA and the Reade Township Board of Supervisors and the approval by our solicitor of all exhibits to the agreement. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye. Tracy Plessinger made a motion to provide an interest free \$10,000 loan to the GVMA to be used for the \$10,000 deposit that the agreement requires. The loan is to be repaid at the closing of the purchase loan. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

#### New Business/Secretaries Report

The secretary reported that the supervisors have been invited to attend the annual GIDA Pig Roast in Coalport on August 14. Any supervisor wishing to attend should contact the secretary by August 7.

We have received a letter from the Coalport Borough Council regarding the possibility of our participation in a regional police force. Based in part on the discussion with Sergeant Bonin it was decided to send a letter to Coalport Borough explaining our belief that any local police force in which we are involved would need to be well trained and equipped and it is unlikely that sufficient funds would be available to field such a force in the Glendale area.

Tracy Plessinger made a motion to approve receipts and disbursements for July. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

James Luther made a motion to approve the treasurer's report for June. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 8:48 PM.
