Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary presented a proposed shared cost agreement with GVMA. The agreement is based on the discussion and decisions at the joint meeting of the township and authority held on June 16. Neal Maneval made a motion to approve the agreement as presented pending approval by GVMA and USDA. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

There was a discussion regarding the proposed on lot sewage ordinance. Approval of this ordinance is necessary in order to move forward with our building project. Tracy Plessinger made a motion to approve the ordinance as presented and instruct the solicitor to advertise said ordinance for final approval. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

There was a discussion regarding creation of the Glendale Recreation Commission. The commission is going to try to organize based on municipal resolutions rather than ordinances. Tracy Plessinger made a motion to approve the resolution creating the Glendale Recreation Commission. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

New Business/Secretaries Report

The secretary reported the GIDA pig roast is scheduled for Tuesday evening, August 12. All township supervisors are invited to attend.

Tracy Plessinger made a motion to approve receipts and disbursements for July. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.
