

June 11, 2007

James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger; GVMA bond counsel, Attorney Jens Damgaard; Tom DeDea, George Coulter, Joe McWilliams, Clyde Hankey, Christian Gohn, Jane Snyder, Bob Munshower, and Rick Gates.

The minutes of the May regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Visitors

Attorney Damgaard presented documents regarding the municipal loan guarantee for the GVMA water project. After his presentation Attorney Damgaard answered questions from the supervisors and the citizens in attendance. Tracy Plessinger made a motion to approve ordinance number 2007-1 guaranteeing the GVMA loan to begin work on the GVMA water project in White Township and to authorize township officials and personnel to execute all related documents and take all related actions. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Public/Supervisor Comment

Several Glendale Yearound residents questioned the supervisors regarding the proposed GVMA purchase of the Glendale Yearound Water and Sewer Companies. Their primary concern is that the income from the Yearound portion of the GVMA system will be used to underwrite the construction and operation of the rest of the GVMA system in White and Reade Townships. The secretary explained that GVMA's current plans are to treat the Yearound portion of the system as a separate rate district, financed independently of the remainder of the GVMA system. While rates in the Yearound will increase over time, those increases will be used to upgrade the existing Yearound systems, not underwrite construction or operation of the system in the remainder of White and Reade Townships. Also, White and Reade Townships are not being asked to guarantee the loans for the purchase of the Yearound systems.

Old Business

The bids were opened for the advertised summer road project. The following bids were received:

New Enterprise Stone and Lime Company, Inc. \$43,619.80

Grannas Brothers Stone and Asphalt Company, Inc. \$43,533.95

Tracy Plessinger made a motion to accept the bid from Grannas Brothers Stone and Asphalt Company, Inc. in the amount of \$43,533.95 and to authorize township officials and personnel to execute all related documents and take all related actions. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Jack Bowling has signed and returned the agreement with the township and CCSEA outlining the procedure that must be followed in order for him to continue to maintain a travel trailer on a non-building lot in the township. The secretary and CCSEA must now monitor Mr. Bowling's compliance.

Mrs. Sandy Shomo has agreed to obtain a dye test and enter an agreement with the township regarding use of an existing septic system on her property on Foster Road. The secretary will prepare an agreement.

Mr. Kevin Hahn has made no decision about how to proceed with his property off of Beaver Valley Road. He is continuing to work with CCSEA regarding on-lot septic for his property.

The secretary reported that he has received no response to our inquiry to Attorney Corcoran regarding his lack of response to numerous phone calls, E-mails, and faxes. Tracy Plessinger made a motion to discharge Richard Corcoran as township solicitor. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye. Tracy Plessinger made a motion to appoint William Gleason Barbin and the firm of Gleason, McQuillan, Barbin, & Markovitz as township solicitor for the remainder of 2007. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

New Business/Secretaries Report

The secretary reported that we have received information from PennDOT regarding the replacement of two bridges on Beaver Valley Road in the 2008 construction season. The bridges cross the Clearfield Creek and Beaver Dam Run. The road will be closed from April through September 2008. PennDOT will maintain one

bridge in operation at all times to allow for the residents living between the two bridges to always have a means of access.

The proposed acquisition of the Glendale Yearround Water and Sewer Companies by the GVMA was discussed previously during the public comment portion of the meeting.

Tracy Plessinger made a motion to approve receipts and disbursements for June. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

James Luther made a motion to approve the treasurer's report for May. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 8:36 PM.
