James Luther, chairman, called the special meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America. The meeting was held in conjunction with the Glendale Valley Municipal Authority's regular monthly meeting.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger (also a GVMA board member); GVMA board members Ken Noel, Rick Stackhouse, Rick Gates, and Jim Krause; residents Maryann Stackhouse, James Ryan, Evelyn Noel, William Davis, Bob Munshower, and Bob Barnhart.

Visitors

Public/Supervisor Comment

James Ryan asked questions about the distances for mandatory tap-in to the sewer system. He owns a hunting camp in the Blandburg area. David Cunningham answered his questions and invited him to visit the Keller Engineer offices to review the plans for the Blandburg area.

Old Business

David Cunningham of Keller Engineers, presented a proposed bid contract for demolition of the existing White Township building to allow for construction of the new White Township/GVMA municipal building. A discussion followed with supervisors, authority members, and citizens participating. Tracy Plessinger made a motion to approve the bid contract and technical specifications for demolition of the existing White Township Building pending approval of same by USDA-RD. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

David Cunningham presented a proposed contract with Keller Engineers for design and inspection of the new White Township/GVMA Building. A discussion followed with supervisors, authority members, and citizens participating. Tracy Plessinger made a motion to approve the contract as presented. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Township secretary/authority chairman, Tracy Plessinger, presented several options for cost sharing of expenses related to the operation and maintenance of the new municipal building. It had been previously agreed to share the construction costs equally. A discussion followed with supervisors, authority members, and citizens participating. Neal Maneval made a motion to approve the following formula for cost sharing. *Individual EDU's (i.e. water and sewer EDU's) are counted separately. Using this method there would be a total of 2,435 EDU's served by the authority. The estimated 2006 population of White Township is 836. That totals 3,271. This would place 74% of the cost on the authority and 26% of the cost on the township. As the number of GVMA customers and the township population change the actual percentages will change.* Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye. Bill Barbin, solicitor, will prepare a draft agreement based on this formula for presentation to both boards and USDA-RD.

David Cunningham reported that soil borings will be done on the treatment plant and building sites in the near future and presented plans for the Fiske section of the sewer and water project for review.

The meeting adjourned at 9:23 PM.
