James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, Charlie Lockey, and Bill Davis.

The minutes of the February regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

#### Visitors

None.

#### Public/Supervisor Comment

Charlie Lockey asked about the possibility of a junk car or junk yard ordinance. The supervisors explained that they intend to be very cautious about implementing such an ordinance. There are several legal problems involved including the definition of a "public nuisance". The secretary reported that in his discussions with other rural townships in our area he has found that there have been problems with trying to enforce such ordinances. The secretary will continue to seek information from other area townships but at present no action was proposed.

Bill Davis asked whether the supervisors have considered the possibility of implementing zoning in anticipation of the municipal water and sewer systems. A brief discussion followed regarding the pros and cons of zoning and sub division ordinances. No action was proposed at this time.

#### Old Business

Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collectors account.

The secretary has prepared a resolution regarding the Glendale Yearound Sewer and Water Systems. The resolution has not yet been reviewed by Attorney Corcoran. No action will be taken until that review is complete.

#### New Business/Secretaries Report

The Glendale Yearound POA has requested that yellow center lines be painted on Swartz Road. The secretary will contact a contractor about doing the work.

The secretary reported that the CCATO Spring Convention will be held on May 5, 2006.

NIMS training is available at the Coalport Fire Hall. The supervisors are scheduled to attend.

The road master will meet with the PennDOT municipal services representative to determine a summer road project.

Tracy Plessinger made a motion to approve the receipts and disbursements for March. Jim Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for February. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 8:28 PM.
