The roadmaster reported that he has met with Bob Mills of PennDOT concerning our summer road project. The estimated cost of paving Black's Lane will be less that the \$10,000 threshold that requires bidding. The secretary will be able to obtain phone quotes for this project. We will try to have the work done by a paving company that is already working in the area to help lower the cost. The roadmaster will investigate doing repairs to the ditches on Swartz Road as a separate project.
