James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger. Larry Noel arrived at 8:00 PM.

The minutes of the April regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Public/Supervisor Comment

None.

### **Old Business**

The CCSEA has sent a letter to Jack Bowling outlining the procedure that must be followed in order for him to continue to maintain a travel trailer on a non-building lot in the township. Mr. Bowling must sign the letter, have it notarized and return it. As yet, there has been no response.

The roadmaster met with Bob Mills regarding a summer road project. The roadmaster recommended paving and shoulder improvements to Swartz Road from the State Route 1021 to the Glendale Yearound entrance. Tracy Plessinger made a motion to approve the road project as presented and advertise same as required. The bids will be opened at the June 11 meeting. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

## New Business/Secretaries Report

The secretary reported that the GVMA has discharged Rich Corcoran due to his lack of availability and failure to respond to numerous phone calls. After discussion, it was agreed that the township should write to Attorney Corcoran and request an explanation for his lack of service to GVMA and assurances that his service to the township will be improved in the future.

The Glendale Valley water and sewer projects are continuing. The GVMA has proposed a longer term of phasing for the sewer project. The new proposal would complete the sewer project in four phases over the course of four funding cycles. Also, the GVMA will be meeting at the White Township building next month immediately prior to the township meeting. The purpose of the meeting will be to approve interim financing for the design and legal fees for the water portion of our project.

The secretary reported that Deborah Sedlmeyer of the CCSEA has inspected a proposed home site for Sandy Shomo. Because there is an existing system, the recommendation is to have the system dye tested and require Mrs. Shomo to enter into an agreement with the township to require her to connect to the municipal sewage system when it becomes available. After discussion, it was agreed to follow the recommendation of the CCSEA. The secretary will notify Mrs. Shomo of her need to acquire a dye test and upon submission of the dye test results to CCSEA will prepare an agreement regarding connection to the municipal system.

The secretary reported that Deborah Sedlmeyer of the CCEEA has inspected a proposed cabin site for Kevin Hahn. Mr. Hahn is requesting permission to place a double wide trailer to be used as a cabin on the site without any water or sewage until testing is completed. The CCSEA is recommending the placement be allowed with an agreement signed to prevent the presence of water under pressure or any type of sewage disposal. After discussion it was agreed to follow the recommendation of CCSEA. The secretary will prepare an agreement for Mr. Hahn's signature.

The secretary received an inquiry regarding whether or not there is a township alley adjacent to the property of Paul Kutruff in Beaver Valley. After checking with former secretary, John Gates, it was determined the former alley was abandoned over fifty years ago. The secretary will notify the inquiring resident of the situation.

We have received correspondence from Penelec regarding our outdoor light. In the next several years Penelec will be discontinuing providing outdoor lights. We will need to decide whether or we want to take over and maintain the existing light or make other arrangements. After discussion, it was decided that the township may not even be in our present building in several years so no decision will be made at this time.


Larry Noel arrived at the meeting at 8:00 PM. He questioned the supervisors about the possibility of digging a hole in Dutch Run for fire protection in Beaver Valley. He also asked about the possibility of building jack

dams on Dutch Run to encourage an increase in the fish population. The supervisors expressed no objection to either project but pointed out that stream management is largely under the jurisdiction of the Cambria County Conservation District and PADEP and proper approvals would have to be obtained for any such projects. Regarding the hole for fire protection, the supervisors also pointed out by next fall there should be municipal water with fire hydrants for protection. It was agreed that the secretary will contact the Glendale Fire Co. about the advisability of digging the hole for fire protection and Mr. Noel will contact members of the Glendale Sportsmen's Club regarding the permits needed for the installation of jack dams.

Tracy Plessinger made a motion to approve receipts and disbursements for May. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for April. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.
