

November 12, 2005

James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, township solicitor Rich Corcoran, Don Yeagle, Kirk McCully, Mike Harpster, Steve Sinclair, and Bill Davis.

The minutes of the November regular meeting were read. Mr. Davis commented that he did not believe that the report given by the secretary constituted an update on the GVMA sewer/water project as it related to the possible purchase of the Glendale Yearound Sewer/Water Systems. The supervisors responded that the report gave all information that was available at the time. Tracy Plessinger made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Public/Supervisor Comment

Mr. Davis questioned the supervisors and Mr. Corcoran about the ongoing negotiations for the possible purchase of the Glendale Yearound Sewer/Water Systems by the GVMA. He also expressed his opinion that the purchase of the system is not in the best interest of Glendale Yearound residents and that the overall sewer/water project is not in the best interest of township residents in general.

Old Business

Neal Maneval has been elected as supervisor to take the seat formerly held by Dr. Soisson. His elected term will begin in January. Tracy Plessinger made a motion to appoint Neal Maneval to serve the remainder of Dr. Soisson's unexpired term. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

The secretary updated the supervisors on the progress of the GVMA sewer/water project. Attorneys for White Township, GVMA, Glendale Yearound Sewer Company and PaDEP are working on a consent decree to allow the GVMA to purchase the Yearound system and eliminate the need for further litigation in this matter. When a tentative agreement is produced it will be presented to all parties for approval.

The secretary reported on the Glendale Valley News Magazine that is being published by GIDA. GIDA will be publishing the next edition in the first week of December. The cost of this issue is being underwritten by GIDA and the sale of advertising to local businesses. GIDA is requesting that each municipality pay the cost of postage for mailing to that municipality. The cost of the White Township portion of the postage is \$68.00. The proposed payment is included in this month's payments.

New Business/Secretaries Report

The federal government is requiring all local officials to undergo National Incident Management System (NIMS) training. This training is being offered in Ebensburg by the Cambria County Dept of Emergency Services. It is also available on the internet. The secretary will check into internet availability.

The secretary presented a tentative budget for 2006. Total income is projected at 96,550. Total expenses are projected at \$93,200. Tracy Plessinger made a motion to approve the tentative budget and advertise same as required. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

Payment of Accounts

Tracy Plessinger made a motion to approve receipts and disbursements for November as presented. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

Treasurers Report

Tracy Plessinger made a motion to approve the treasurer's report for October. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

Meeting adjourned at 7:58 PM.
