

November 13, 2006

James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger, Bill Davis, Joseph Budzinski, Bonnie Plessinger, and Madalyn Plessinger.

The minutes of the September regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Visitors

Ryan Plessinger addressed the board regarding support for his Eagle Scout project to erect a war memorial honoring White Township residents who have served in the US armed forces. Tentative approval of the project is required in order for him to submit the project for scout review and approval. Neal Maneval made a motion to express the township's support for the project pending submission of complete plans and funding information. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

Public/Supervisor Comment

Mr. Budzinski addressed the board regarding a "reverse subdivision" for his lots in the Glendale Yearound. The supervisors explained that based on the advise of our solicitor, we are not able to provide reverse subdivisions because we have no subdivision ordinance and we no longer have responsibility for sewage disposal in the Glendale Yearound. In addition, there are deed restrictions on all Yearound properties that may prohibit such a "reverse subdivision". The secretary will mail Mr. Budzinski a written response to his inquiry.

Old Business

Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collector's account.

The secretary updated the supervisors on the progress of the Glendale Valley water/sewer project. Our applications have been submitted and are pending USDA Rural Development approval. Currently the projected tap fees are \$1000 for water and \$1500 for sewer. There will be grant and loan programs available to help low income residents with these fees.

We have received signed agreements from all our winter maintenance contractors.

We have received notice that our 2006 County Aid monies have been encumbered for use in future road projects.

The secretary still has not received a letter of resignation from the township's Emergency Management Coordinator to confirm his verbal resignation.

New Business/Secretaries Report

The secretary presented the tentative budget for 2007. The budget projects total income of \$114,150, total expenditures of \$95,800, with a surplus of \$18,350. Proposed tax rates for 2007 are 1.5 mils for Real Estate, \$5.00 for Emergency and Municipal Services Tax, 0.5% for Real Estate Transfer, and 0.5% for Earned Income. James Luther made a motion to approve the tentative budget for 2007 and advertise same as required by the Township Code. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The PADEP has sent a letter to Mr. Tom Ross informing him of possible requirements regarding his proposal to connect to the Noel/Zimmerman Sewage Treatment Plant. After consulting with our Sewage Enforcement officer and engineering firm, the secretary has prepared a letter detailing the township's requirements for such a connection. Tracy Plessinger made a motion to send the letter as presented to Mr. Ross. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the receipts and disbursements for November. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for October. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 7:55.
