James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther and Tracy Plessinger, township solicitor, Rich Corcoran, Bill Davis, Charles Lockey, Bill Creager & Tom Charney.

The minutes of the September regular meeting were read. Tracy Plessinger made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

Visitors

Charles Lockey and several other citizens addressed that Board of Supervisors concerning their concerns over the accumulation of junk cars on properties in the township. They renewed their request that the supervisors consider enacting an ordinance to eliminate and/or regulate disposal of junk vehicles and other bulky waste. Attorney Corcoran spoke to the pros and cons of such ordinances and the difficulty in enforcement of same. No action was taken at this time. The supervisors will continue to consider this issue.

The secretary reported that Quaker Sales has completed the paving of Black's Lane and Flinton Road. Bob Mills has performed a final inspection and recommended that the edges of the pavement be backed up with stone to prevent breakage. The secretary will order stone and the road master will take care of getting it put in place.

The secretary updated the supervisors on the progress of the GVMA sewer/water project. The GVMA and RTMA will be holding a joint meeting on October 13 to consider approval of a water purchase agreement. If this agreement is approved, the project will be able to move forward.

The secretary reported on the Glendale Valley News Magazine that is being published by GIDA. GIDA has requested that each municipality participate in the publication by paying the postage to mail to its residents and businesses. The cost of the White Township portion of the postage is \$68.00. After discussion it was determined to present the postage for payment with next month's invoices.

Tracy Plessinger made a motion to accept Ms. Helbig's letter of resignation and send a certified letter requesting that she surrender all records to the secretary before next month's meeting.
