James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger.

The minutes of the September regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Visitors

None.

Public/Supervisor Comment

Road Master James Luther commented that he had inspected Oshall Road and Swartz Road. The drainage problem on Oshall Road can be corrected with minimal hand work. The road master will contact McClellan Excavating about doing drainage work on Swartz Road.

Old Business

Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collector's account.

The secretary updated the supervisors on the progress of the Glendale Valley water/sewer project. An application for funding for the water system has been submitted and applications for both phases of the sewer project will be submitted in this month. Also, after once again reviewing the option of having sewage from the Glendale System treated the GVMA has determined that it is not a feasible option. A letter has been sent to the BCI Municipal Authority with copies going to GVMA board members and Reade and White Township supervisors explaining the reasons for this decision.

The CCBCEA has received a letter from PADEP certifying that the Glendale Yearound Sewage System has capacity to treat sewage for additional structures. Based on this certification the CCBCEA will continue to issue building permits for the Glendale Yearound development.

New Business/Secretaries Report

The secretary reported that we must give tentative approval to the 2007 budget at our November meeting. The budget must then be advertised and made available for public inspection before it can receive final approval at our December meeting.

We have received a letter from GIDA requesting a contribution of \$68 for postage costs for mailing the Glendale Valley News to White Township residents. The secretary has included the amount in the bills to be approved for payment this month.

We have received a letter from Slovikosky Excavating proposing to plow specified township roads for an annual fee of \$7,480. After discussion, Tracy Plessinger made a motion to offer Slovikosky Excavating a three year contract at the requested amount. James Luther seconded the motion. A vote was taken. All three supervisors voted aye. The secretary will forward a contract to Slovikosky Excavating for signature.

The secretary has been informed by the township's Emergency Management Coordinator that he is resigning that position. The secretary requested a written letter of resignation for approval at next month's meeting.

Tracy Plessinger made a motion to approve the receipts and disbursements for October. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for September. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.
