### Old Business

In addition to the crushing the septic tank, the power has now been disconnected from the Tom Ross property. The CCBCEA has contacted REA and requested that under no circumstances should the power be reconnected until proper permits are acquired. It appears as though the mobile home on the property is unoccupied.

The secretary reported that Quaker Sales will be completing the paving of Black's Lane and Flinton Road this month. After the work is done the secretary will contact Bob Mills about doing a final inspection.

The secretary updated the supervisors on the progress of the Glendale Valley News, a municipal newsletter sponsored by GIDA. The first issue is being completely underwritten by GIDA and was mailed to every household in the five municipalities represented by GIDA. It was mailed on September 1.

# New Business/Secretaries Report

The secretary presented a letter of resignation from Dr. Fred Soisson. Dr. Soisson has moved from the area and will not be able to fill the remainder of his term. Tracy Plessinger made a motion to accept, with regret, Dr. Soisson's resignation. James Luther seconded the motion. A vote was taken. Both supervisors voted aye. A discussion followed concerning the possibility of appointing a replacement for Dr. Soisson. Since the election to fill Dr. Soisson's seat will take place in November, it was agreed to allow the seat to remain vacant pending the outcome of that election.

The secretary reported that the township has received a letter from the Mountaindale Community Development Corporation requesting a letter of support from the township for their project to develop the Mountaindale Conference Center. Tracy Plessinger made a motion to send the requested letter of support. James Luther seconded the motion. A vote was taken. Both supervisors voted aye.

Tracy Plessinger made a motion to pay bills as listed on treasurer's report and approve same. James Luther seconded the motion. A vote was taken. All three supervisors voted aye. Treasurer's report is attached. Meeting adjourned at 8:07 PM.
