Central Tax Bureau is continuing to review past year's tax receipts to determine the proper distribution of the money on deposit in the former EIT collectors account.

The secretary reported that we have received no response from PADEP to our letter restating our intent to adhere to our resolution releasing the township from all obligations regarding the Glendale Yearound water and sewer systems.

The secretary reported on the progress of the Glendale Valley sewer and water project. The GVMA is continuing to pursue funding with USDA Rural Development. Bob Noel, Reade Township Supervisor, and Jack Rupp, Coalport Borough Councillor, attended the GVMA meeting last month and requested that we reconsider connection to the BCI sewage system. Keller Engineers is once again calculating the cost of such an option. Any change in the proposed system would require a change in the township's Act 537 plan. Keller Engineers will report to the GVMA board at the September meeting about this option.

New Business/Secretaries Report

The Fall Convention of the CCATO will be held on Friday, September 29.

We have received a request for a donation from the Home Nursing Agency. No action was taken.
