James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger.

The minutes of the August regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

#### Old Business

Bids were received and opened for building construction on August 28, 2008, as advertised. The bids received were as follows:

- Earthmovers Unlimited, Inc. - \$37,447.00
- Earth Shapers, LLC - \$42,575.00
- Manspeaker Excavating and Trucking, Inc. – \$45,000.00
- Daversa Construction Corp. – \$37,550.00

The bids have been reviewed for completeness by our engineer and they recommend accepting the bid from Earthmovers Unlimited, Inc. Tracy Plessinger made a motion to award the bid for building demolition to Earthmovers Unlimited, Inc. and to authorize township officials to execute all necessary agreements pertaining to the bid award. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The PUC has approved the purchase of the Yearound systems by GVMA. No appeals are known to have been filed. Both parties are hoping to close by the end of September.

The road master reported that he has been in contact with Tri-County Tree Service about trimming trees on Swartz Road. He will continue to work with them to schedule the needed work.

#### New Business/Secretaries Report

Tracy Plessinger made a motion to continue winter maintenance agreements with Clearfield and Reade Townships at the PennDOT winter maintenance rate. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported that he has had no luck in trying to get Highway Marking to paint lines on Swartz Road when they are working in the area. After discussion, it was decided that the line painting should be postponed till Spring 2009. The secretary will contact Yingling Line Painting Service about doing the work in the spring.

Tracy Plessinger made a motion to approve receipts and disbursements for September. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for July. Neal Maneval seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 7:50 PM.
