James Luther, chairman, called the regular monthly meeting of the White Township Board of Supervisors to order at 7:00 PM. The meeting began with the pledge of allegiance to the flag of the United States of America and the Lord's prayer.

Those present included supervisors James Luther, Neal Maneval, and Tracy Plessinger.

The minutes of the August regular meeting were read. Neal Maneval made a motion to approve the minutes as presented. Tracy Plessinger seconded the motion. A vote was taken. All three supervisors voted aye.

The secretary reported that the supervisors and GVMA board held a joint executive session for personnel matters on Tuesday, August 25, 2009.

Old Business

The secretary reported that the building project is complete and final payment has been made to the contractor. The enclosure around the night deposit box was not included in the original bid. The secretary has received a quote of from Hoff Enterprises to construct and install the enclosure.

The secretary updated the supervisors on the status of the Jack Bowling sewage complaint. Attorney Barbin has filed a petition with the court. A hearing date will be set.

Letters have been sent to EP Bender Coal Company, PA State Police, and PennDOT regarding speeding coal trucks on Church Hill Road. PennDOT responded in writing saying that they could not could not pull the road bonding because of the infractions. The PA State Police responded with a phone call saying that they would try to increase patrols in the area. EP Bender Coal Company did not respond.

There was a discussion of the shared services agreement with GVMA. In order to allow the shared manger/sec-treas to participate in the PA Municipal Retirement System (PMRS) our solicitor has recommended that we amend our agreement to make the shared employee an employee of the township rather than the authority. James Luther made a motion to amend the shared services agreement with GVMA to make the shared employee an employee of the township rather than the authority. All other provisions of the agreement remain unchanged. Neal Maneval seconded the motion. A vote was taken All three supervisors voted aye.

Neal Maneval made a motion to pay the shared manager/sec-treas a salary of \$37,838 (\$28,000 GVMA share/\$9,838 township share). James Luther seconded the motion. A vote was taken. Neal Maneval and James Luther voted aye. Tracy Plessinger abstained.

Neal Maneval made a motion to provide health insurance coverage for the shared manager/sec-treas through the Cambria County Healthcare Consortium and to follow the same policies as the county regarding employee contributions to the plan. James Luther seconded the motion. A vote was taken. Neal Maneval and James Luther voted aye. Tracy Plessinger abstained.

New Business/Secretaries Report

The secretary reported that he has been called to report for jury duty. If he is selected for the jury the trial could take up to three weeks. In that case, the township office would be unstaffed for that time.

The 100th Annual Convention of the Cambria County Association of Township Officials will be held on Friday, September 25 at the Lemon Drop Lounge.

We have received notification from DCNR that it is going to be doing work on the boat docks at Glendale Lake this winter. No lowering of the water level will be necessary.

There was a discussion of snow removal contracts for the 2009-2010 season. The roadmaster has requested quotes giving a rate for a snow removal season. The rate is to be paid in two installments with the rate constant over a three year period. Three quotes have been received for winter maintenance on the roads on the west side of the township. They are as follows:

Slovikosky Excavating – \$7,980/season

K & G Services - \$8.450/season

Joe Luther's Landscaping - \$8,250/season

Tracy Plessinger made a motion to grant a three year contract to Slovikosky excavating at a rate of \$7,980/season for three years and to extend contracts with Reade Township and Clearfield Township for another year at the PennDOT rate. All contracts will be paid in two installments. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to contract with Joe Luther's Landscaping for parking lot and walkway snow removal at the municipal building. The cost will be \$55/event for snow plowing and \$10/bag for salt applied. Neal Maneval seconded the motion. A vote was taken. Tracy Plessinger and Neal Maneval voted aye. James Luther abstained.

Lines have been painted on Swartz Road. There are still few trees along the road that are partially blocking the stop sign. The secretary will contact Bill Barnhart at the Glendale Corporation about cutting these trees.

The road master reported that most of the delineators marking culverts and cross drains have been destroyed. The secretary will order 40 yellow and 10 white delineators.

Tracy Plessinger made a motion to approve receipts and disbursements for September. Neal Manavel seconded the motion. A vote was taken. All three supervisors voted aye.

Tracy Plessinger made a motion to approve the treasurer's report for August. James Luther seconded the motion. A vote was taken. All three supervisors voted aye.

Meeting adjourned at 8:35 PM.
